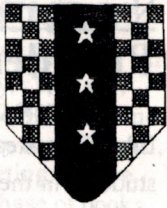

## President's Message

The past two months have been very busy at the Fiske Library: a steady flow of members doing research, new students in the classes, and a large number of new books for the collection.

If you haven't been in recently, you owe yourself the opportunity that a fresh look at the collection will provide! The Fall Tour to New England brought back boxes of new books from throughout that section of the country. Several people have made contributions from their own collection of resource materials and the Library has traded duplicates with Heritage Quest, to the benefit of both centers. The growing shelf-list has necessitated the rearrangement of the space assigned to some of the state's to accommodate these new resources. Both the Fiske Board and the Friend's organization have budgeted funds for continuing new acquisitions.

The New England Historical and Genealogical Society continues to have a close relationship with the Fiske Library. They treated our Fall Tour participants well when the group was in Boston and they have been cooperative in sharing discarded books with us. David Brazier, from the Fiske Board has visited Boston on several occasions as he helps them complete a computer-based catalog of their collection, which will be going on line for public access this month. On April 16, 1999, Henry Hoff from NEHGS will present a one-day seminar at Fiske on New York Genealogy. Be sure to save the date! The following day, April 17th, will be the Fiske Fair. (Better save that date, too!)

To assure that the Fiske collection is being well used, the Board has decided to clarify its circulation and rental policy, providing an incentive to return materials promptly so that others may have access to them. Elsewhere in this issue, you will find a copy of the new policy, which became effective on November 1st. In essence, the rental fee of \$1 per week will increase to \$2 per week after the fourth week and we are asking that users pay their rental fee in advance. Of course, the Board is always open to suggestions and feedback on any of the operating guidelines of the Library.

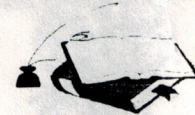

## TRAVELERS RETURN FROM NEW ENGLAND

Although they were unhappy because their plane arrived home almost two hours late, the New England visitors still had smiles on their faces. They had memories of a wonderful trip, successful research, spectacular scenery, interesting historical sights, and very congenial traveling companions. Betty Kay Anderson was responsible for the entire trip, working very hard each day to plan activities, and even driving one of the vans over 1,000 miles herself through all kinds of traffic, and over strange roads.

Highlights named by the participants include:

Research at NEHGS library in Boston, Connecticut State Library at Hartford, and the Historical Society library in Concord, N.H. Also a visit to Redwood Library in Newport, R.I. Shopping stops at several used book stores, and the purchase of over \$2000 worth of books to bring home for our own library. (Thanks go to Roy Anderson for packing them for the plane ride.)

Visits to the homes of John Alden, Robert Frost, John Adams, Harriet Beecher Stowe, the Vanderbilt mansion, and the House of the Seven Gables. Also, the Norman Rockwell museum. Dinners at the Wayside Inn, the lobster house at Gloucester (where juice dripped from many elbows), and the Hilltop Steak house, as well as frequent ice cream stops along the way.

The colorful fall foliage everywhere, but especially at "Dream Lake", a small but picturesque spot reminding many of us of Washington state. Also a covered bridge in a beautiful setting. Lexington and Concord history, Plymouth colony history, as well as Salem witchcraft stories from the past. Ask any one of the participants about this exciting trip. Betty Kay has a story about someone she forgot, Dolores has a story about a tree that she carried for two weeks, and Frank Peters has several interesting stories about "side-trips" he saw while driving some of the group members about the countryside. Everyone agreed, it was an "awesome" trip!

up to an additional four weeks. Materials held for over 8 weeks are past due and further access to the library by the borrower is proscribed until the materials are returned in satisfactory condition.

Reference books and materials used with high frequency do not circulate. (Some of these volumes have been marked by a red dot on the spine of the book.) Rare books in the glass case never circulate. Material in the loose-leaf binders throughout the library must be used on the premises; none of these resources circulates. CD-Rom materials are considered to be reference materials and must be used on the premises.

The Fiske Genealogical Library offers its circulating collection through inter-library loan to reciprocating libraries.

## Tips From Arthur's Tip Sheets:

### Corruption of Christian Names

Alice, Elsie - Garbled forms may include: Elle, Alse, Elsa, Alce, Ellie, Elic, etc.

Mary - may be Maria, Mara, Marah, and even Mercy, although Marah and Mercy may be distinct names. Also Polly.

Mariah, pronounced Mar-eye-ah, is a form of Mary, but usually not to be confused with Mary. There are examples of Mary, Mariah, and Marianne, three separate children, in the same family.

Judy, the standard nickname for Judith can be confusing when written Jude (i.e. Jud-ee) or Judah (pronounced Judy).

Forms of names known on the continent of Europe may puzzle the American researcher if those names have been altered or translated into an English form. Among the most unusual encountered by the writer is the German name Gottfried (English equivalent: Godfrey). Gottfried in one Virginia instance generated into Cutlip.

Names that have been used in masculine and feminine instances give trouble. We are familiar with a few, but formerly there were many more. Among the names encountered by the writer (in addition to the usual Francis-Frances and Marian-Marion) are: Beverly, Lorraine, Shirley, Pearl, Ethel, Hazel, Vivian, Abijah, Sharon, Carol, Fay and others.

The Puritan names in New England give difficulty. Several of the "names of Christian Virtues" are interchangeable between masculine and feminine. Some examples: Comfort, Waitstill, Experience, Dependence, Love, etc.

Biblical names may in some instances be either masculine or feminine. Examples: Abial and Abijah. Phonetic spelling of names is troublesome: Unis = Eunice, Febe = Phebe, Luce = Lucy. Or "illiterate" spelling: Easter = Esther, or Louis = Lois.
